Human Rights, the Sustainable Development Goals & the Law 2020 International Online Symposium & Hon Justice CD Gonthier Memorial Lectures

Friday, 15 May 2020

Canada and all countries, through the United Nations, have committed to global Sustainable Development Goals (SDGs), tackling the toughest social, environmental and economic challenges of our century. Across 17 SDGs with 169 targets, human rights play a critical role as legal obligations, policy drivers and principles shaping practical collaboration. However, significant implementation gaps exist, as evidenced in Voluntary National Reports (VNRs) submitted to the UN by Member States. As countries implement new strategies for the SDGs, ongoing challenges on all levels highlight the complexities of harnessing rights-based approaches to the SDGs in law, policy and practice. New connections, skills and knowledge can help fill this SDG implementation gap, through interdisciplinary review of rights-based approaches highlighted in VNRs, recent law and policy reforms, tribunals and treaties. In current times, as countries design new post-pandemic recovery strategies and policies for the SDGs, informed dialogue between experts, academics and practitioners, while building skills in rights-based approaches and engaging SDG-focused institutions, offers opportunities for outstanding learning and impact.

The international symposium on **Human Rights, the Sustainable Development Goals and the Law** will be held on May 15, 2020, co-hosted online by the Centre for Human Rights and Legal Pluralism at McGill University and the Centre for International Sustainable Development Law (CISDL), in cooperation with the University of Montreal Faculty of Law, the University of Cambridge Centre for Energy, Environment and Natural Resources Governance (CEENRG), the University of Waterloo School of Environment, Enterprise and Development (SEED), the Balsillie School of International Affairs (BSIA), the International Law Association of Canada, the McGill Journal of Sustainable Development Law (MJSDL), Canada's Sustainable Development Solutions Network, the IUCN's World Commission on Environmental Law Climate Change Specialist Group, and many other generous partners.

The evening features the biennial **Hon Justice CD Gonthier Memorial Lectures**, which after brief opening remarks by the Rt Hon Chief Justice Richard Wagner of the Supreme Court of Canada, are given by Acting Executive Secretary Dr Elizabeth Mrema of the Convention on Biological Diversity, former Director of Environmental Law for the United Nations (UN) Environment Programme and the Hon Justice Professor Marcel Szabo of the Constitutional Court of Hungary, former Ombudsman for Future Generations his country's UN Human Rights Commission.

Keynote speakers and interactive online dialogue will focus on three key themes, as identified by the UN Office of the High Commissioner for Human Rights, which may be essential for post-pandemic law and policy measures: *Transformation:* As an agenda for "people, planet, prosperity, peace and partnership", the SDGs offer a paradigm shift from

the traditional model of development, providing a transformative vision for post-pandemic measures that are people and planet-centred, human rights-based, and gender-sensitive.

* **Comprehensiveness:** Alongside a wide range of social, economic and environmental objectives, post-pandemic measures which contribute to the SDGs will promote "more peaceful, just and inclusive societies which are free from fear and violence" with attention to democratic governance, rule of law, access to justice and personal security (in Goal 16), as well as an enabling international environment (in Goal 17 and throughout the framework). They cover issues related to all human rights, including economic, civil, cultural, political, social rights and the right to development.

* *Inclusion:* Post-pandemic measures which contribute to the SDGs will leave no-one behind, envisaging "a world of universal respect for equality and non-discrimination" between and within countries, including gender equality, by reaffirming the responsibilities of all States to "respect, protect and promote human rights, without distinction of any kind as to race, colour, sex, language, religion, political or other opinions, national and social origin, property, birth, disability or other status."

This global online event convenes national and international experts and leaders together with emerging scholars, students and practitioners, to explore new research trends, challenges and insights in implementing the SDGs through a rights-based approach and to share innovative solutions and lessons in designing post-pandemic legal and policy measures to achieve the SDGs while advancing universal human rights.
