Biodiversity & Biosafety Programme

Dr. Claudia Ituarte-Lima



Dr. Claudia Ituarte-Lima has specialized on environmental law (biodiversity and climate law) and human rights in theory and practice for the past twenty years. She examines major legal and governance challenges on environmental justice and the transformation of international law into new governance forms that support healthy ecosystems and people's wellbeing. Her methodology ranges from case studies and collaborative research in Latin America, Southeast Asia and Eastern Africa, to legal analysis examining the interactions of international legal regimes. Her synergizing experiences include having worked in academia, civil society organizations and government. Claudia is a researcher fellow at Stockholm University,

senior researcher at Raoul Wallenberg Institute of Human Rights and Humanitarian Law and visiting scholar at University of British Columbia. (PhD University College London and MPhil University of Cambridge).
