Leverhulme Lecture & Distinguished Experts Dialogue **Event Outline**

Complex, inter-linked 'wicked problems' of climate change, natural resources degradation, drought and hunger, terrestrial and marine ecosystem collapse and species extinction, and worldwide health pandemic risks, among others, have been warned by scientists and civil society, with increasing urgency over recent decades. The United Nations Sustainable Development Goals (SDGs) offer a common global environmental, social and economic public policy agenda, supported by binding international treaty obligations and regimes.

This Leverhulme Trust, Lecture and Distinguished Experts Dialogue on 17 March 2021 engages leading international jurists and academics and renowned natural resources management experts to share insights and identify new directions for natural resources management and the global Sustainable Development Goals, guided by international law and policy.

After a welcome from Professor Stephen J Toope, Vice-Chancellor of the University of Cambridge, this special 'evening/lunch' online event is chaired by the Rt. Hon Professor Nico Schrijver, Professor Emeritus of Public International Law of the University of Leiden Law School, State Councillor in the Netherlands Council of State and former President of the International Law Association. Rt Hon Lord Jonathan Mance, Baron Mance, former Deputy President of the United Kingdom Supreme Court and Chair of the International Law Association worldwide, has kindly agreed to give opening remarks.

Laying foundations for discussion, the online **Leverhulme Lecture**, opened by <u>Professor Diane Coyle</u> Co-Director of the Bennett Institute for Public Policy, University of Cambridge, shall be provided by <u>Professor Marie-Claire Cordonier Segger</u> as Leverhulme Trust Visiting Professor at the University of Cambridge. She is also Senior Director, Centre for International Sustainable Development Law (CISDL); Full Professor of Law in the University of Waterloo, Canada; author of Sustainable Development Law (OUP), Sustainable Development in International Courts and Tribunals (Routledge) and other volumes; laureate of the 2020 HE Judge CG Weeramantry International Justice Award; and Rapporteur of the ILA Committee on the Role of International Law in Sustainable Resources Management for Development. <u>Prof. Ilaria Espa</u>, Professor at the Swiss Italian University in Lugano and Senior Research Fellow at the World Trade Institute, who hosted the final ILA Committee conference leading to the Guidelines, shall provide the lecture closing thanks.

The feature is a **Distinguished Experts Dialogue** between respected international judges, expert professors of international law, heads of international treaty secretariats and international institutes in the field of law, public policy and sustainable development. This series of open public Leverhulme Lectures raises complex, inter-linked 'wicked problems' of climate change, drought and hunger; natural resources mismanagement; terrestrial and marine ecosystems degradation and rising global poverty and injustice. It considers how the United Nations Sustainable Development Goals (SDGs) offer a common global public policy agenda, supported by binding international legal principles and rules derived from treaty regimes, interpreted by courts and tribunals. In the present lecture, experts consider how international law, including dispute settlement, can foster more sustainable management of the world's fragile resources, advancing new directions for research, education and practice in this field. Nearly 1,400 people have already registered, from a wide diversity of backgrounds, including judges, ministers, professors, senior practitioners, civil society and business leaders, key government and international officials, university and college students and members of the public.

Chair

State Councillor Professor Nico J. Schrijver is Professor Emeritus of Public International Law at Leiden University, and former Academic Director of the Grotius Centre for International Legal Studies. Currently, he serves as State Councillor, Division of Legislation, in the Council of State of the Netherlands, a judge ad hoc in a Special Chamber of ITLOS and member of the Curatorium of The Hague Academy of International Law. He is former Senator in the Dutch House of Parliament, where he served as the chairperson of the Committee on Foreign Affairs, Defense and Development Co-operation, and leader of the Dutch delegation of the Parliamentary Assembly of the Council of Europa. Nico Schrijver is also member of the Institut de Droit International since 2007 and served as its president during 2017-2019, and member of the Royal Netherlands Academy of Arts and Sciences. During 2010-2012 he served as the president of the worldwide International Law Association and during 2008-2016 he was a member and vice-chair of the UN Committee on Economic, Social and Cultural Rights. Since 1995 he is visiting professor of The European Union and Co-operation with Developing Countries at the Université libre de Bruxelles. His books include Sovereignty over Natural Resources. Balancing Rights and Duties, The Evolution of Sustainable Development in International Law, and Development Without Destruction. The UN and Global Resource Management.

Welcome, University of Cambridge

Vice-Chancellor Professor Stephen J. Toope, OC, LLD, PhD (Cambridge), AB (Harvard), BCL/LLB(McGill), Vice-Chancellor, University of Cambridge, is a distinguished scholar and academic leader. His academic interests lie in international law, human rights, international environmental law, and international legal theory. His books include Legitimacy and Legality in International Law: An Interactional Account and After the Paris Attacks: Responses in Canada, Europe, and Around the Globe; his articles regularly feature in leading international journals. He served as the Chair and Rapporteur of the United Nations Working Group on Enforced and Involuntary Disappearances; Former Chair of the Board of Universities Canada and President of Canada's Federation for the humanities and Social Sciences; Previous consultant to Canada's Department of Foreign Affair and International Trade, the Canadian International Development Agency, and many other United Nations' agencies. Among the distinctions he has received are the Queen Elizabeth II Silver Jubilee Medal and the John Read Medal of the Canadian Council of International Law.

Opening Remarks, International Law Association

The Rt Hon Lord Jonathan Mance, Baron Mance, is former Deputy President of the United Kingdom's Supreme Court. He sat from 1993 to 1999 as a Commercial Judge, was appointed to the Court of Appeal in 1999, and to the House of Lords in 2005 where he spent four years as a Law Lord before becoming a Justice of the Supreme Court on its formation in 2009 and its Deputy President in 2017-2018. Since joining 7 King's Bench Walk, Lord Mance has been appointed in a wide range of arbitrations (in a majority of cases as sole arbitrator or chair, but also as a wing arbitrator) under ICC, LCIA, UNCITRAL and ICSID Rules and ad hoc in fields including insurance/reinsurance, energy, joint venture, construction and investment. Lord Mance is currently Chair of the International Law Association, Chair of the Conduct Committee of the House of Lords, and a member of the Judicial Integrity Group (responsible for the Bangalore Principles on Judicial Conduct). He also sits as an appellate judge of the Singapore International Commercial Court and is Chief Justice of the Astana International Commercial Court. He was, among others, a founder director of the Bar Mutual Indemnity Insurance Fund Ltd and chaired various Banking Appeals Tribunals.

Introduction, Bennett Institute for Public Policy

Professor Diane Coyle, CBE, LLD, PhD (Harvard), BA (Oxford), Professor Diane Coyle is the inaugural Bennett Professor of Public Policy at the University of Cambridge. Diane co-directs the Bennett Institute where she heads research under the themes of progress and productivity, and has been a government adviser on economic policy, including throughout the covid-19 pandemic. Her latest book, 'Markets, State and People – Economics for Public Policy' examines how societies reach decisions about the use and allocation of economic resources. Diane is also a Director of the Productivity Institute, a Fellow of the Office for National Statistics, an expert adviser to the National Infrastructure Commission, and Senior Independent Member of the ESRC Council. She has served in public service roles including as Vice Chair of the BBC Trust, member of the Competition Commission, of the Migration Advisory Committee and of the Natural Capital Committee. Diane was Professor of Economics at the University of Manchester until March 2018 and was awarded a CBE for her contribution to the public understanding of economics in the 2018 New Year Honours.

Professor Marie-Claire Cordonier Segger, DPhil (Oxon), MEM (Yale), BCL&LLB (McGill), BA Hons (Carl/UVic), FRSA is Leverhulme Visiting Professor, University of Cambridge; Senior Director, Centre for International Sustainable Development Law; Executive Secretary, UNFCCC CoP26 Climate Law & Governance Initiative; Rapporteur of the ILA Committee on the Role of Sustainable Resources Management for Development (2012-2020) and an award-winning expert jurist and professor of law and governance in the field of sustainable development. Author/editor of 22 books, including Sustainable Development Law (OUP) and Sustainable Development in International Courts and Tribunals (Routledge); also the Cambridge University Press Series on Sustainable Development Treaty Implementation; and over 80 papers, Professor Cordonier Segger also serves on the editorial boards of five law journals. She is a full professor of international law at the University of Waterloo, Canada; chairs several experts commissions and the Future Board of Bit Bio, an award-winning Cambridge biomedical firm; and as former senior civil servant, International Development Law Organization senior legal expert; and general counsel to UN and IUCN treaties, advises countries on implementing climate change, biodiversity, natural resources, trade and investment accords related to sustainable development. She is also Fellow in Law / Graduates Director of Studies in Lucy Cavendish College; Visiting Professor of Bennett Institute for Public Policy; co-founder and Fellow of the Cambridge Centre for Environment, Energy and Natural Resource Governance (CEENRG) and the Hughes Hall Centre for Climate Change Engagement (CCCE); Affiliated Fellow of Lauterpacht Centre for International Law; and Laureate of the Justitia Regnorum Fundamentum Prize, the HE Judge CG Weeramantry International Justice Award and other honours.

Conclusion of Lecture

Professor Ilaria Espa, Dr lur (Bocconi University), MA (LUISS), BA (LUISS), is Senior Assistant Professor of International Economic Law at USI Lugano, Senior Research Fellow at the World Trade Institute (WTI) in Bern and Adjunct Professor at the Catholic University of the Sacred Heart in Milan. She is furthermore Lead Counsel of the Natural Resources Programme of the Centre for International Sustainable Development Law (CISDL) since 2021. Formerly awarded a Marie Curie fellowship from the European Commission for her post-doctoral studies (2013-2015), Ilaria was a member of the WTI-based NCCR Trade Regulation Programme (2013-2017) and also an Adjunct Professor at the Department of Environmental Science and Policy of the University of Milan (2015-2020). She served as a member of the ILA Committee on the Role of International Law for the Sustainable Management of Natural Resources for Development (2014-2020) and was conferred the 2020 CISDL International Legal Specialist in Natural Resources Award. She is an elected member of the Executive Council of the Society of International Economic Law and the Secretary-General of the Swiss Energy Law Association.

Closing Remarks

H.E. Judge Tomas Heidar, B.A. & LL.M. (Iceland), has been a Member of the International Tribunal for the Law of the Sea (ITLOS) since 2014 and serves as Vice-President of the Tribunal since October 2020. He was President of the Chamber for Fisheries Disputes 2017-2020. He is a Member of the Special Chamber formed to deal with the Dispute concerning delimitation of the maritime boundary between Mauritius and Maldives in the Indian Ocean (Mauritius/Maldives). From 1996-2014, he served as Legal Adviser of the Ministry for Foreign Affairs of Iceland, attaining the rank of Ambassador. As such, he was responsible for all matters of public international law, in particular the law of the sea. Judge Heidar is also Director of the Law of the Sea Institute of Iceland and Co-Director of the Rhodes Academy of Oceans Law and Policy. He lectures at the University of Iceland and many other universities and institutions around the world, such as University College London, Queen Mary University of London, the International Foundation for the Law of the Sea Summer Academy in Hamburg and the Yeosu Academy of the Law of the Sea. He has also taught law of the sea at the United Nations Regional Course in International Law in Ethiopia. Judge Heidar has published a number of articles and books in the field of the law of the sea and recently edited New Knowledge and Changing Circumstances in the Law of the Sea (Brill Nijhoff, 2020).

Dr. Ilaria Bottigliero is the Director of Policy, Research and Learning at International Development Law Organization. Prior to joining IDLO, Dr. Bottigliero was Lecturer and Researcher at the Raoul Wallenberg Institute of Human Rights and Humanitarian Law in Lund, Sweden, and at the Lund University Faculty of Law, teaching a variety of human rights courses. Dr. Bottigliero has extensive specialized expertise in victims' rights, gender and international criminal justice.

Dr Susan Breau is Dean of the Faculty of Law at the University of Victoria, in British Columbia, Canada. She was the Head of the School of Law at the University of Reading, UK from 2014-2018, and has a distinguished record of achievement as a researcher, teacher and administrator.

Professor Thomas Cottier is the former Managing Director of the World Trade Institute and WTO Panellist and is now Professor Emeritus of European and International Law at the University of Bern. He has served as a member or chair of several GATT and WTO panels and currently serves as one of the ten arbitrators for the Multi-Party Interim Appeal Arbitration Arrangement (MPIA). He held several positions in the Swiss External Economic Affairs Department and was the Deputy-Director General of the Swiss Intellectual Property Office. He is the President of the Swiss Energy Law Association.

Dr Amy Fraenkel is the Executive Secretary of the Convention on the Conservation of Migratory Species of Wild Animals. She has over 30 years of experience in international environmental law and policy. She has held senior positions in UN agencies, the legislative and executive branches of the U.S. Government, and the private sector.

Wendy J. Miles, QC, LLM (Canterbury), BA LLB (Canterbury), Barrister and Solicitor, Twenty Essex, Vice President of the ICC Court of Arbitration, ICC Commission on Arbitration and ADR, Co-Chair of the task force on Arbitration of Climate Change Related Disputes, is a specialist in international arbitration and dispute resolution with a focus on private and public international law. She regularly publishes articles in prominent international law journals, often focusing on in the link between Climate Change, Policy and Finance. She has advised a wide range of multinationals, including corporates,

sovereign States, State Entities and multilateral State organisations. She is special advisor Nigel Topping, the UK Government High Level Champion on Climate Action; acts as global coordinating counsel for major corporates in relation to climate change transition, disclosure, reporting, compliance and investment.

Dr Kent Nnadozie is the Secretary of the International Treaty. Prior to his appointment as Secretary, he was the Senior Officer of the International Treaty, overseeing various technical areas of the Programme of Work of the Secretariat. Before joining FAO, Mr Nnadozie was in private legal practice and academic research. He has extensive practical experience in related international processes and legal instruments.
